Students should possess a positive attitude and a sense of commitment in their talent area.

FREQUENTLY ASKED QUESTIONS

1. Who can apply for DSA?

All Primary 6 students can apply for DSA-Sec based on the wide-range of talents offered by the school of their choice.

2. How do I apply?

Application for DSA-Sec can be submitted through the online DSA-Sec Portal. The application is free-of-charge and will be opened from 4 May 2023 to 31 May 2023. For more details, please refer to MOE website – <u>www.moe.gov.sg/dsa-sec</u>.

- 3. When and how will I know the results of my DSA-Sec application? All applicants will be informed of the results of their application by email. See DSA-SEC Timeline for details.
- 4. When and how will I know the results of my DSA-Sec allocation results? Your child's DSA-Sec allocation results will be released along with the PSLE results. Collect the results at your child's primary school.

If your child is not studying in a mainstream primary school, you will receive the DSA-Sec allocation results via email.

5. My child is not in a MOE school. What is the application procedure? The application is made up of 2 parts: (1) Getting a registration number and (2) Accessing the DSA-Sec portal with the given registration number. 6. What is the frequency and duration of training?

Training is conducted usually twice a week for 2.5 hours. However, training hours will be extended during competition or performance periods.
